If assistance is provided due to disability, the assister must complete the affidavit on the reverse of this form. Each candidate must also complete a Candidate's Consent form (CAN-20). This petition must be filed with the appropriate county voter registration office for processing no earlier than January 10, 2018 and no later than NOON, July 2, 2018. School Board Candidates should use a CAN-34 form, not this form. *Presidential Candidates* must complete the certification of presidential elector candidates on the reverse of this form. Consult your attorney to be advised of your rights and responsibilities.
